

**Selectmen's Meeting**  
**August 1, 2007**

1. A public hearing was held on an application for building permit submitted by DiSandro for a dock, ramp and float. There was no public comment.
2. Reviewed applications for abatement of property tax:
  - ✓ Ulin, tax map 14 lot 48: Hanna moved to reduce acreage from 3.5 to 3.2 and to abate for one year. The motion was seconded by Tibbetts and carried 3-0.
  - ✓ Lakin, tax map 28 lot 21: Denied. The Assessors could not identify any errors in assessment. Parker Appraisals will be asked to review.
  - ✓ Scott, tax map 5 lot 20G: Denied. The Assessors could not identify any errors in assessment. Parker Appraisals will be asked to review.
