

Selectmen's Meeting February 15, 2017 MINUTES

Selectmen Present: *Chad Hanna, Terry Lowd, Paul Yates.* Also Present: *Chris Hall (Town Administrator)*

[The Selectmen met following the end of the final 2017 Budget Committee meeting, which voted recommendations on the budgets for Parks and Recreation and Bristol Fire and Rescue, and requests from non-profit groups.]

Selectmen were called to order by chair Chad Hanna at 7.30 pm, followed by the Pledge of Allegiance.

Approval of Minutes

• A motion was made by Lowd to approve the minutes of February 8th, seconded by Yates and carried 3-0.

Old Business:

- Budget. Noted that the Budget Committee had completed its work and that every Article submitted had received an affirmative vote. Hanna moved and Lowd seconded that Selectmen recommend to the Town all articles customarily subject to a recommendation by Selectmen, as now written and recommended by the Budget Committee. Passed 3 – 0.
- Town Administrator Hall presented the Warrant for the Town Meeting, subject to final wording of School Article 16 and inclusion of the recommendation votes made this day by the Budget Committee and Selectmen. The Warrant will be sent for printing on Friday February 17 and seven originals will be available for Selectmen's signatures on Wednesday 22nd.

Miscellaneous correspondence:

- A letter was received from the Town's attorney in connection with a potential noise nuisance complaint in Round Pond. Hall reported that the attorney asked that selectmen take the letter away to read in full

and she would be prepared to discuss it at a future Selectmen's meeting.
