4. **Mapping Project:**

The revised map was presented by Colleen Hendricks and Lindsay Currier; it includes input from members, Coastal Rivers Conservation Trust and the Rt 66 Snowmobile Group. New features include points of origin/destination, and the route 66 snowmobile trail.

The committee requested that the snowmobile trail be enhanced with crosshatching for enhanced display, and that inserts and a key of the points of origin/destination be created. One correction regarding the correct identification of Upper Round Pond Rd was noted. Committee members were advised to submit any other feedback to Lindsay this week and Colleen would be submitting a finalized version of the map at the end of the week.

The map will be used in conjunction with the survey, with future updates by Lindsay to promote access to Bristol Byway routes.

5. 2019 Bristol Bicycle Pedestrian Survey:

The survey was reviewed, and after much discussion, it was determined that committee members will forward to Lindsay any changes, corrections, and additions for the survey. She will compile the data and send it out as a voting email.

The committee agreed that distributing the survey as soon as possible is beneficial so we can get feedback from summer residents. A discussion of how to promote the survey and distribute it led to the conclusion that it should be available to complete both on and off-line, reaching as many residents and non-residents as possible.

The committee discussed how the short term goal of the survey was to identify and prioritize potential projects to propose to the 2020 Budget Committee and potentially Town Meeting, with the long term goal being the creation of a five+ year plan to safely connect Bristol's residents and visitors with the beauty of the Pemaquid peninsula, its communities, and its neighbors.
