



**BRISTOL BYWAYS COMMITTEE**  
**(formerly Bicycle Pedestrian Committee) Minutes**  
**Tuesday November 18th, 2019, 6:30 pm – Town Office**

Introduction of present members and non-present members:

The meeting was called to order by Co-Chair Chuck Farrell at 6:30pm, followed by the Pledge of Allegiance.

It was moved by Fitzpatrick, seconded by Albright, to accept the Minutes of November 5th, 2019 as presented. Motion passed 6-0

**Voting on Recommended Actions**

Prior to voting the group discussed and clarified the recommended action items. The concern expressed by J Albright that Round Pond's needs were not adequately addressed was answered. Per B Faunce, in the long term, he would see the hiring of a consultant to evaluate all three villages for sidewalks and crosswalks.

Snowmobile signage was clarified: RT 66 club needs to file an application with the MaineDOT to get the approval for signs on state roads; the town would need to cover the expense for the signs. T Richards reminded the committee that there are town road crossings that would not require DOT involvement for placement.

C Farrell will speak with Ms Westhaver in the Town Office regarding the need to appropriate any legal fees which may result from these recommendations.

B Faunce noted that some of the recommended actions may be eligible for grant money from Lincoln County Regional Planning Commission.
